OFFICE ORDER


In pursuance of Govt. of India Department of Pension and PW , New Delhi **Office Memorandum No. 57/05/2021-P&PW(B) dated 03.03.2023** and endorsed by the Finance Department, Govt. of NCT of Delhi vide NO. F.20/07/2022/Finance (Policy)/951-959 dated 12.04.2023, stating that, it has now been decided that, in all cases where the Central Government civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, **prior to the date of notification for National Pension System i.e. 22.12.2003** and is covered under the National Pension System on joining service on or after 01.01.2004, may be given a onetime option to be covered under the CCS(Pension) Rules, 1972 (now 2021).

In accordance with the OM dated 03.03.2023 and the option exercised by Sh. Sachin Kumar, Sr. Asstt. regarding coverage under the CCS (Pension) Rules, 1972 (now 2021), the matter was examined as per the available records, it is established that Sh. Sachin Kumar (D.O.B. : 04/10/1979), S/o Sh. Manveer Singh, was appointed against the post or vacancy which was advertised/notified for recruitment/appointment prior to the date of notification for National Pension System i.e. 22.12.2003.

Accordingly, I am directed to convey the approval of Appointing Authority i.e. Controller of Accounts being Head of Department **to cover the Services of Sh. Sachin Kumar, Sr. Asstt. under the Central Civil Services (Pension) Rules, 1972 (now 2021)** (Old Pension Scheme) in place of National Pension System from the date of his appointment i.e. 09.04.2005.


