Sub: Allotment of DDO Codes to SNA Scheme Managers under SNA SPARSH Model.

Department of Expenditure, Ministry of Finance, Government of India (PFMS Division) vide OM F.No.I(27)/PFMS/2020 dated 13th July, 2023 issued revised procedure to be followed by State Governments/UTs for the release of Centrally Sponsored Schemes through e-kuber platform of RBI in SNA SPARSH model.

2. As per the said OM, State Governments/UTs are required to develop a Cyber Treasury which will function as single point interface for carrying out all payment transactions through integration of States/UT's IFMS Portal with that of PFMS and RBI e-kuber.
3. Accordingly, this office vide letter dated 11.8.2025 declared PAO-13 as Cyber Treasury for carrying out all payment transactions through integration of States/UT's IFMS Portal with that of PFMS and RBI e-Kuber.
4. In view of above, the following CCS schemes which have been accorded approval for opening of Account in RBI, are allotted DDO code as under and are hereby attached with PAO-Cyber Treasury, DFS Building, Shanker Road, New Delhi:


