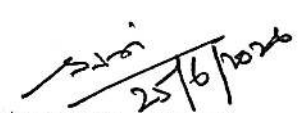

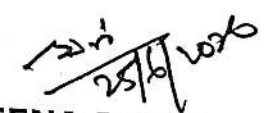

CIRCULAR

Subject:- On-boarding on iGOT Karmayogi Platform under "Mission Karmayogi".

"Mission Karmayogi" or the National Programme for Civil Services Capacity Building, aims to bring comprehensive reforms to the existing capacity building framework, at both, the individual and organizational level for efficient public service delivery. Further, it also aims to prepare Indian Civil Servants for the future challenges by making them more creative, constructive, imaginative, pro-active, innovative, progressive, professional, energetic, transparent and technology-enabled.

2. Registration on iGOT Karmayogi platform is mandatory for all officers of Accounts Cadre of Government of NCT of Delhi. All officers (CCA/COAs/DCAs/Sr.AOs/AAOs) of Government of NCT of Delhi Accounts Cadre must undertake courses of individual choice (3 training module for level 8 to 11 and 2 training module for level 12 and above). The courses chosen should be relevant to their work requirements and to enrich their capacities. The Government of NCT of Delhi Accounts Cadre officers may also opt for paid courses on iGOT portal; in which case, the cost of such course may be refunded upto Rs. 10000/- per year by the concerned departments/autonomous bodies. **The course shall be completed by 30.09.2026.**

3. Further, all the Government of NCT of Delhi Accounts Cadre officers are hereby directed to ensure the successful registration on "iGOT Karmayogi online training platform" **within 03 days positively** and complete the training Modules on iGOT as mentioned above and furnish the details, in the following format to Human Resource Division, Cadre Control Unit, Finance Department through email at **Sanjay.k.shrivastava@delhi.gov.in, latest by 31.07.2026:-**
