No Vigilance Case is Pending or is being Contemplated against the official in this department, however, a FIR No.-03/2008 PS-ACB U/sec.-13(1)(d) and 13(2) POC Act r/w/sec. 420/468/471/406/379/120-BIPC was registered against the official in 2008. The official was discharged by the Hon'ble Court of Sh. Narottam Kaushal, Special Judge (PC Act)-05, (ACB), (Central), Tis Hazari Courts, Delhi vide order dated 04.06.2013. As per the status report provided by ACB on 24.09.2024, the ACB went in Appeal before High Court of Delhi, where appeal is pending and will be listed in due course. An undertaking to this effect has also been obtained from the concerned official.
