1. Short title	and commencement:- (i)	These rules may be called "The Principal - Grade-II & Driver-Grade-II" Recruitment

- Accounts Office Driver, Ordinary Grade, Driver Grade-II & Driver-Grade-I" Recruitment Rules, 2023.
- 2. **Number of posts, classification and Pay Level in the pay matrix**:-The number of post, its classification and Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, Age limit and other Qualifications, etc:**-The method of recruitment to the said post, age limit and other qualifications and other matter relating thereto shall be as specified in the columns (5) to (13) of the said Schedule.
- 4. **Disqualifications:-** No person,
 - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) Who having a spouse living, has entered into or contracted a marriage with any person;

shall be eligible for appointment to the said post:

Provided that the Government may, if satisfied that such marriage is permissible under the personnel law applicable to such persons and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rule.

5. **Power to relax:** Where the Government of National Territory of Delhi is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect of any class or category of persons.

6. **Saving:**- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Exservicemen and other special categories of persons in accordance with the orders issued by the Government of National Capital Territory of Delhi from time to time in this regard.
