**Sub: Declaration of Pay & Accounts Office-13 as "PAO-Cyber Treasury" for SNA SPARSH Model -- Just-in-Time release of Centrally Sponsored Schemes (CSS) Funds.**

Department of Expenditure, Ministry of Finance, Government of India (PFMS Division) vide OM F.No.I(27)/PFMS/2020 dated 13th July, 2023 issued revised procedure to be followed by State Governments/UTs for the release of Centrally Sponsored Schemes through e-Kuber platform of RBI in SNA-SPARSH model.

As per the said OM, State Governments/UTs are required to develop a Cyber Treasury which will function as single point interface for carrying out all payment transactions through integration of States/UT's IFMS Portal with that of PFMS and RBI e-Kuber.

Accordingly, the Competent Authority has declared Pay & Accounts Office-13, DFS Building, Shanker Road, New Delhi as **"PAO-Cyber Treasury"** in addition to the existing functions already assigned.

The said **"PAO-Cyber Treasury"** will commence work from the date of onboarding of the first scheme on to the GNCTD's SNA-SPARSH platform, developed by NIC Delhi State Unit.
