Saving occurred mainly under the following Sub Heads: -.

1. Under Major Head "2012" – President, Vice President / Governor Administrator of UTs – Administrator of UTs – Secretariat – Saving of ₹288.76 lakhs (against the sanctioned provision of ₹1238.40 lakhs inclusive of supplementary provision of ₹100.90) was mainly due to non finalisation of arrears against various posts, non-filling of some vacant post & 10% mandatory cut in non plan expenditures.

Under Major Head "2070" - Other Administrative Services - Special Commission 2. of Enquiry – Lokayukta – Saving of ₹132.97 lakhs (against the sanctioned provision of ₹380.00 lakhs) was mainly due to vacant posts, non receipt of various bills as anticipated & also due to effecting economy instructions.

Further saving of ₹60.81 lakhs remained under one sub-head which exceeds ₹50.00 lakhs but less than ₹1.00 crore.

In the Voted portion of Revenue Section of the grant, the overall saving of ₹17138.29 lakhs (against the sanctioned provision of ₹37186.50 lakhs inclusive of supplementary provision of ₹2705.00 lakhs) constituted 46.08% of the total sanctioned provision.

Provision of ₹23.55 lakhs remained wholly un-utilised under three sub-heads.

Savings occurred more than ₹1.00 crore mainly under the following sub heads: –

- 1. **Under Major Head "2013"** Council of Ministers Other Expenditure -- Savings of ₹340.83 lakhs (against the Sanctioned provision of ₹658.00 lakhs) was mainly due to purchase proposal & foreign tour proposal not materialised.
- 2. Under Major Head "2052"- Secretariat General Services -- Secretariat (a) Chief Secretariat Savings of ₹252.35 lakhs (against the Sanctioned provision of ₹3881.35 lakhs) was mainly due to vacancies, less publication & advertisement, anticipated bills not received & tour proposals not materialised.
 - (b) Home Department Savings of ₹412.97 lakhs (against the Sanctioned provision of ₹632.00 lakhs) was mainly due to vacancies & less claims.
 - (c) Office of the Council of Ministers Savings of ₹469.07 lakhs (against the Sanctioned provision of ₹829.50 lakhs) was mainly due to vacancies, less claims, purchase proposals & tour proposals not materialised & non drawl of 7th CPC allowance.
- 3. Under Major Head "2235" Social Security and Welfare Other Social Security and Welfare programme Swatantrata Sainik Samman Pension Scheme Pension to freedom fighters in Delhi Pensionary Charges Saving of ₹124.30 lakhs (against the sanctioned provision of ₹350.00 lakhs) was mainly due to less claims.
- 4 Under Major Head "2070" Other Administrative Services (a) Special Commission of Enquiry Public Grievances Commission Saving of ₹121.04 lakhs (against the sanctioned provision of ₹400.00 lakhs) was mainly due to vacancies & less claims/bills.

- (b) Training Dte. Of Training Saving of ₹281.64 lakhs (against the sanctioned provision of ₹926.00 lakhs) was mainly due to vacancies, less claims and mid-career mandatory training for DANICS officers could not be materialized and procurement of materials not materialised as planned.
- (c) Vigilance Dte. Of Vigilance Saving of ₹798.96 lakhs (against the sanctioned provision of ₹1724.00 lakhs) was mainly due to vacancies, less claims/bills, non finalisation of proposals, non materialisation of procurement proposals & anticipated expenditure.
- 5. Under Major Head "2220" Information and Publicity Films Direction and Administration Public Relation Directorate. Saving of ₹13602.61 lakhs (against the sanctioned provision of ₹20768.00 lakhs) was mainly due to less claims/bills, non filling of vacant posts, non finalisation of purchase proposals of computers & non finalisation of bills of violative advertisement.
- 6. **Under Major Head "2051"** Public Service Commission Staff Selection Commission Staff Selection Board for Delhi Govt. Savings of ₹808.52 lakhs (against the sanctioned provision of ₹2007.50 lakhs) was mainly due to vacant posts, less claims/bills & Conduct of less examination.
- 7. **Under Major Head "2052"** Secretariat General Services Secretariat New Initiative and Administrative Reforms -- Savings of ₹280.13 lakhs (against the sanctioned provision of ₹300.00 lakhs) was mainly due to less bills & payment could not be made to NICSI.

Further saving of ₹168.62 lakhs remained under two sub-heads which exceeds ₹50.00 lakhs but less than ₹1.00 crore.

The above savings were partly off-set by an excess under the following sub head:-

1. Under Major Head "2055" – Police – Welfare of Police Personnel – GIA to Delhi Computerisation of Police Service Society for Crime and Criminal tracking System (CSS) – Excess of ₹645.97 lakhs (against the supplementary provision of ₹305.00) was mainly due to receipt of funds from Govt. of India.
