Saving occurred mainly under the following sub-heads: –

1. Under Major Head "2014" – Administration of Justice – High Court – (i) Direction and Administration – Saving of `779.90 lakhs (against the sanctioned provision of `14339.50 lakhs inclusive of supplementary provision of `354.50 lakhs) was mainly due to non-filling up of vacant posts, less foreign tours and less installation of solar water Heating System.

Further savings of `133.76 lakhs remained under two sub heads which exceeds `50.00 lakhs but less than `1.00 Cr.

In the Voted portion of Revenue Section of the grant, the overall saving of `4864.50 lakhs constituted 9.95% of the total sanctioned provision.

Saving occurred mainly under the following heads: –

- 1. Under Major Head "2014" Administration of Justice (a) High Court Delhi Judicial Academy Direction & Admn. Saving of '301.40 lakhs (against the sanctioned provision of '555.00 lakhs) was mainly due non-shifting of Delhi Judicial Academy to new premises.
 - (b) Civil & Session Courts (i) Session Court Saving of `1144.46 lakhs (against the sanctioned provision of `32540.00 lakhs) was mainly due to non digitalization of old records and non settlement of bills and vacancies.

- (c) Criminal Courts Judicial Magistrate's Courts Saving of `604.17 lakhs (against the sanction provision of `3962.00 lakhs) was mainly due to digitalization process not conducted and non settlement of bills.
- (d) Administration of Justice-special Courts-Grant-in —Aid to Delhi Distpute Resolution Socity Saving of `125.00 lakhs (against the sanction provision of `300.00 lakhs) was mainly due to bifurcation of grant.
- (e) Administrator of Justice Special Courts Establishement of family Courts saving of `257.28 lakh (against the sanctioned provision of `1000.00 lakhs) was mainly due to non receipt of approval from the Competent Authority and non filling up of vacant posts.
- 2. Under Major Head "2015" Election (a) Charges for conduct of Election to the State/UT Legislature Expenses on Election Saving of `1718.24 lakhs (against the sanctioned provision of `3500.00 lakhs) was mainly due to bifurcation of election expenditure to district level.
 - (b) Issue of identity cards to voters—Saving of `312.71 lakhs (against the sanctioned provision of `1025.00 lakhs) was mainly due to receiving of less claims / bills.
 - (b) Preparation and Printing of Electoral Rolls Saving of `729.41 lakhs (against the sanctioned provision of `1000.00 lakhs) was mainly due to bifurcation of election expenditure up to district level and receiving of less claims / bills.

Further saving of `305.05 lakhs remained under four sub-head which exceeds `50.00 lakhs but less than `1.00 crore.

The above savings were partly off set by an excess under the following sub-heads: -

- 1. Under Major Head "2014" Administration of Justice Civil & Session Courts Computerisation of Distt & Session Courts Excess of `239.85 lakhs (against the sanctioned provision of `200.00lachs) was mainly due to more expenditure on computerization of Courts
- 2. Under Major Head "2015" Election Charges for conduct of Elections to Parliament Lok Sabha Elections Excess of 411.19 lakhs (against the sanctioned provision of `350.00 lakhs) was mainly due to Lok Sabha Eelections.
